Helårsperson

Helårsperson = aktive dage i perioden / antal kalenderdage i perioden
Eksempel: En person har en aktiv sag i et givent år fra d. 1. marts til d. 20 april.

Marts: aktiv dage = 31, kalenderdage = 31. Helårsperson: $31/31 = 1$.
April: aktiv dage = 20, kalenderdage = 30. Helårsperson: $20/30 = 0,67$.
Året: aktiv dage = 51, kalenderdage = 365. Helårsperson: $51/365 = 0,14$.

Helårsperson

Helårsperson = aktive dage i perioden / antal kalenderdage i perioden

Eksempel: En person har en aktiv sag i et givent år fra d. 1. marts til d. 20 april.

Marts: aktiv dage = 31, kalenderdage = 31. Helårsperson: $31/31 = 1$.

April: aktiv dage = 20, kalenderdage = 30. Helårsperson: $20/30 = 0,67$.

Året: aktiv dage = 51, kalenderdage = 365. Helårsperson: $51/365 = 0,14$.
